

HELPING PARENT BUY OUT AGREEMENT FORM

In order to meet the changing needs of our parents, we are offering **2 Buy Out Options for Helping Parent Responsibilities**. Parents who choose to buy out of their Helping Parent responsibilities will still need to provide a snack on their child's assigned Helping Child day. Parents who choose **not** to buy out will **not** be given additional days. Please note the following important information:

- The child without a Helping Parent on his/her assigned Helping Child day will still be the Helping Child in the classroom. Their name will appear with an "(S)" next to it on the calendar indicating that the parent will be sending in a snack for the class that day.
- The child without a Helping Parent on his/her assigned Helping Child day may choose to arrive 10 minutes prior to the start of class to help the teachers with set up but are not required to.
- Parents who choose to buy out can still volunteer to be a Helping Parent on their child's assigned days. Please give the teacher 48 hours notice if you will be coming in.
- You may trade your Helping Child's day with another parent, but please notify the Helping Child Coordinator as soon as the change is made.
- Participating in the Helping Parent Buy Out refers to the "in classroom" responsibility only. All families are required to fulfill their committee responsibilities and meet all other membership requirements as set forth in the Handbook.
- The Buy Out will be in effect from September 9, 2014 – May 29, 2015.

If you would like to participate in one of our Helping Parent Buy Out Options, please fill out the following form and return it to the office along with your check made out to "DNPCCNS" prior to September 1, 2014.

Please choose one of the following options

_____ **OPTION #1: Full Buy Out** **\$395.00**

By participating in a Full Buy Out Program, I understand that I will not be required to fulfill any in-classroom helping parents responsibilities from September 11, 2013 – May 30, 2014.

_____ **OPTION #2: Half Buy Out** **\$225.00**

By participating in a Half Buy Out Program, I understand that I will be required to fulfill an approximated half of any in-classroom helping parent responsibilities from September 11, 2013 – May 30, 2014 as noted below.

2 day / week class = 3 Helping Parent Days* in the classroom

3 day / week class = 4 Helping Parent Days* in the classroom

4 day / week class = 4 Helping Parent Days* in the classroom

**Your child will be placed on the Helping Child schedule, in a regular rotation, which is distributed in the Directory at the September General Membership Meeting. You will be responsible for reviewing the schedule and choosing which of those days you would like to come in to fulfill your Helping Parents responsibilities as listed above. Please contact the Helping Child Coordinator with your chosen dates by September 30, 2014.*
